Anyone having their boat lifted by the Fond du Lac Yacht Club will read and sign the following statement:

The Fond du Lac Yacht Club assumes no responsibility for damage or loss to boats or other personal property stored or lifted with us, whether or not caused by fire, lightning, water, cyclone, tornado, windstorm, hail, explosion, theft, malicious mischief, collapse of building, or other hazard or causality of any kind or any combination of the forgoing or other hazards or casualties and whether or not caused by our negligence or act or failure to act. Every boat owner is urged to insure their property at all times in a suitable amount against all possible hazards and casualties.

This application for storage must include a Certificate of Insurance or a photocopy of the Declaration Statement showing minimum liability coverage of \$100,000 or storage may be considered. It is the policy of the Club that your boat be insured while on Club grounds.

Our lay up season is the first Saturday after Labor Day to May 15th. No boats are permitted on the City lots prior to October 1st. After May 15th, there will be a penalty of \$20.00 per day for each day beyond May 15th, but no longer than 15 days. If the boat needs to be moved by the Fond du Lac Yacht Club, an additional \$200.00 fee will be assessed. Owners must shore their own boats, furnish their own shoring, and be present or a have authorized agent present, when boat is lifted.

NO EXCEPTIONS WILL BE MADE TO THESE RULES.
