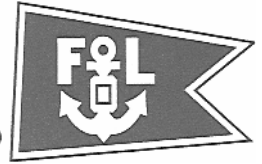

APPLICATION FOR WINTER STORAGE

Anyone wishing to reserve winter storage at the Fond du Lac Yacht Club is urged to complete and return this form to the club no later than September 1st. To insure the storage space, a \$30.00 reservation fee is required. This reservation fee is non-refundable and is not applied to lift and storage fees.

 Storage fees are \$7.50 per boat foot for club members, and \$12.50 per foot for non-members with an additional charge for state tax. The owner must make his or her own arrangements for a lift operator. A list of approved operators is posted at the club. The above fees include lifting, storage, and placing of boat back into the water in the spring.

Owner(s) **MUST BE PRESENT OR HAVE AN AUTHORIZED PERSON BE PRESENT** when their boat is being lifted. It is the owner's responsibility to prepare the cradle for storage. Anyone wishing to store a boat at the Fond du Lac Yacht Club **must show proof that the boat is insured for liability while on the club grounds**. Application for storage must include a Certificate of Insurance or a photocopy of the Declaration Statement showing a minimum liability coverage of \$100,000 or the request for storage will not be considered.

Club policy sets the storage season as the **first weekend after Labor Day through May 15th**. Boats remaining on the yard at other times will be assessed a per day penalty as established by the Board of Directors.
